## Business Unit Pumps & Systems

NETZSCH Pumpen & Systeme GmbH is the head of the Business Unit Pumps & Systems. In addition to the production site in Waldkraiburg, Germany, there are four other subsidiaries with their own production facilities in Brazil, China, the USA and India, along with branches in Argentina, Australia, Austria, Belgium, Canada, France, Great Britain, Indonesia, Italy, Kazakhstan, Malaysia, Mexico, the Netherlands, Poland, Russia, Singapore, Spain, South Africa, South Korea, Thailand and the United Arab Emirates, as well as agencies in many other countries.

### Company history

The parent company of the corporate group, which was founded in Selb, Upper Franconia, in 1873, obtained the licence to manufacture and sell the NEMO® pump in 1951. This pump is designed according to the Moineau principle (NEtzsch + MOineau = NEMO), also known as a progressing cavity pump. This pumping principle is suited to numerous sectors and areas of application.

In 1961, its success led to the foundation of an independent company within the NETZSCH Group, NETZSCH Pumpen & Systeme GmbH, with its registered office in Waldkraiburg. A second plant was built in 1987 to meet the requirements for greater space and modern manufacturing techniques. The product range grew rapidly over the decades and now also includes TORNADO® rotary lobe pumps, dosing systems, grinders and comprehensive accessories. A third plant was therefore acquired in 2009, which houses dosing technology. Currently there are two other buildings under construction, the elastomer production and the TechLab, which will be completed in October 2013.

### Corporate structure

NETZSCH is constantly further developing its comprehensive range of pumps with various designs, sizes, material options and accessories, which means it offers the appropriate pump for virtually every area of application. The areas of application determine the company's sales organization, which is split into the Business Fields Environmental & Energy, Chemical, Pulp & Paper, Food & Pharmaceutical, Oil & Gas and Dosing Technology. Waldkraiburg is home to complete parts manufacture, tool and jig construction, the design and

development department, training facilities and training rooms, along with the sales and distribution center. Up to 150 pumps can be manufactured on a daily basis. Annual production is around 45,000 pumps.

How did NETZSCH become a global market leader?

NETZSCH's importance on the global market is based on the combination of tradition and progress. Qualified staff in every plant work on the development and testing of new versions and sizes of pumps. NETZSCH attaches the greatest importance to strict quality control. The whole production process is run on the basis of the quality assurance system in accordance with DIN EN ISO 9001. NEMO® and TORNADO® pumps are manufactured to meet various national and international standards, as well as individual customer requirements. After the purchase of a pump, our service team provides customer care in a reliable and helpful way.
